How to find us

By train
Bournemouth - 3 miles

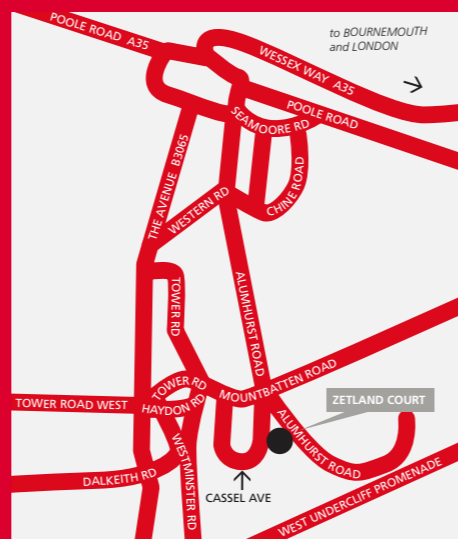
By bus
Take bus number 24 from the bus stop located at Bournemouth train station. The number 24 stops outside the Home, ask for Beaulieu Road, Westbourne.

By car
From London/Southampton. Follow M3 to Junction 1, then join M27. Follow signs to Bournemouth and The West. M27 becomes A31, follow A31 for 11½ miles.

At the Ashley Heath roundabout, turn left onto A338 (signposted to Bournemouth). Keep on this road and after the Richmond Hill turn off, get into the right-hand lane. The road becomes a single lane leading up to the County Gates Gyratory (a large roundabout with the Liverpool Victoria building on it). Stay in the left-hand lane (marked Westbourne) and take the second exit onto B3065 (The Avenue) signposted to Sandbanks and Compton Acres.

At the first traffic lights, turn left into Western Road and at the roundabout, turn right into Alumhurst Road. After about ½ mile, turn right into Mountbatten Road.

The Home is immediately on the left.

Zetland Court



Built in the 1840s, this magnificent house was redesigned and refurbished in the early 1980s. It is situated in its own grounds, a short walk from the beach in a peaceful area of Westbourne, near Bournemouth. The grounds are beautifully landscaped and well-maintained, providing pleasant areas to sit and walk with sufficient space for disabled access.

Zetland Court is registered for residential and nursing care with the dual benefits of individual rooms and shared communal areas. The categories of care offered are dependent upon people's assessed individual needs.

Here is a snapshot of our services at Zetland Court:

General facilities and services available

The whole premise of the RMBI is to create a home rather than an 'institutional style' environment, both inside and out. Zetland Court can accommodate up to 63 residents providing both residential and nursing care. All rooms are centrally heated and some are en-suite, a small number of double rooms are available for married couples. Residents may furnish their own room with small items of furniture if they wish, provided that the furniture meets the required safety standards.

On each corridor there are bath/shower facilities especially adapted for safe usage so that residents maintain their independence in a safe environment. Kitchenettes are available where residents can make drinks and snacks for themselves or their visitors.

The Home has its own hairdressing salon where residents can enjoy pampering from a professional hairdresser.
