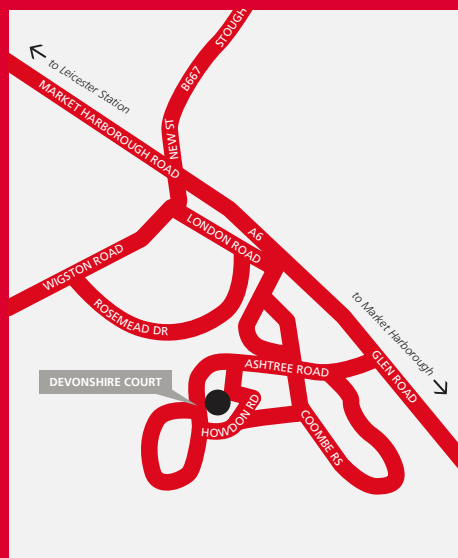
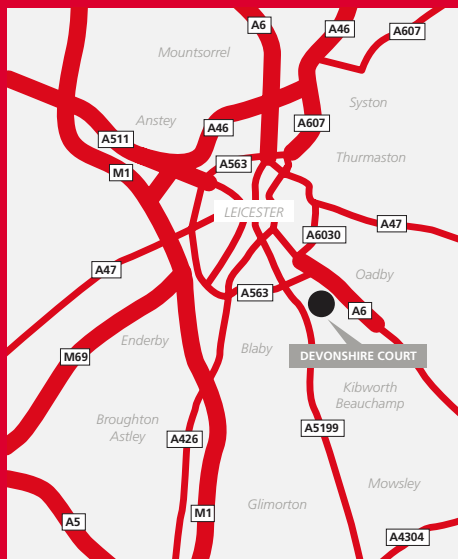
Leicester - 5 miles

(M69 Junction 3) onto A563 south.
After 5 miles turn right onto A6
towards Market Harborough (Leicester
Road, which becomes Harborough
Road and then Glen Road). Follow
A6 for approximately 1.5 miles. At
Sainsburys (on right), turn right into
Ash Tree Road. Continue almost to
end and turn left into Van Dyke Road.
After road bends to left take 1st right
into Howdon Road, the Home is on the
right.

Devonshire Court



Devonshire Court was the first purpose-built RMBI Care Home and the first residents moved into the Home in 1966. The Home is situated on a four and a half acre site in a pleasant residential area. The grounds are beautifully landscaped and include a putting green, providing pleasant areas to sit and walk. A garden and a patio area accessible from the conservatory also provide a tranquil place for residents to enjoy.

The residential and nursing part of the Home operates a traditional 'hotel' style of care – where residents share communal facilities. The categories of care offered are dependent upon people's assessed individual needs.

General facilities and services available

The whole premise of the RMBI is to create a home rather than an 'institutional style' environment, both inside and out. Devonshire Court can accommodate 67 residents offering residential, nursing and dementia care. All rooms are single, centrally heated, furnished bed sitting rooms with en-suite toilet facilities. Residents may furnish their own rooms, if they wish, provided that the furniture meets the required safety standards.

The Dementia Support Unit is set in its own enclosed secure gardens and provides care and support to residents with dementia.

On each corridor of the main Home there are bath/shower facilities especially adapted for safe usage so that residents maintain their independence in a safe environment. Kitchenettes are available where residents can make drinks and snacks for themselves or their visitors.

Devonshire Court offers a wide range of recreational facilities including a well stocked library with a full range of books and audio tapes to suit many needs. Social and other activities are an important aspect of the care at the Home. Residents are encouraged to remain active for as long as they are able. A full programme of activities is organised by our Activities Co-ordinator and includes a variety of arts and crafts in our activities room, entertainment, events and trips to various places of interest.

The Home has its own hairdressing salon where residents can book appointments for haircuts and styling from a professional hairdresser.
