Roll of Honour contributions

The Roll of Honour is produced to celebrate donations to the Good Neighbour Fund. The Roll of Honour enables contributions to be acknowledged in a special way.

Membership options

Individuals - Brethren, Ladies and Companions can be included on next year's Roll of Honour by making a donation of at least £10.

Alternatively there are four levels of Life membership and individuals can appear on all future Rolls of Honour by making a donation of at least £100. Donations are cumulative and Diamond membership can be attained over time.

Lodges, Chapters and other Orders - These groups can become Corporate Annual Members (for one year only) by making a donation of at least £25.

Alternatively, Corporate Life Membership can be achieved at four levels (Silver, Gold, Platinum or Diamond). Minimum donation levels for these range from £250 (Silver) to £1,000 (Diamond). These donations are cumulative. This means, for example, that a Silver Membership can be upgraded to Gold by making a further donation of £250 in the following year.

In addition to an Annual or Life Membership, you can also make a donation to honour this year's President, RW Bro Geoffrey Dearing, Provincial Grand Master for East Kent.

The Good Neighbour Fund

The Good Neighbour Fund is used to provide holidays each year for Brethren and their dependants, who might not otherwise have the opportunity to have a break. Those selected will usually be in receipt of a Masonic Relief Grant from the Grand Charity.

Each year 70 holidays are offered to four holiday locations; Llandudno, Bournemouth, Southend on Sea and Eastbourne. Each holiday is for two weeks and includes half board accommodation in comfortable ensuite rooms, usually in 3 star hotels. The RMBI use the same hotels each year where possible, so that staff are aware of the needs of the RMBI group holidaymakers.

The holidays include a full agenda of visits and activities. Local Freemasons at all locations put a great deal of effort into supporting and entertaining the holiday parties. They organise visits to Masonic points of interest, visits to local RMBI homes and trips to areas and sites of interest. At the end of each two week holiday, a cocktail party is held followed by a farewell gala dinner.

Without the help of your donations to initiatives such as the Roll of Honour and with the help of local Freemasons, these holidays would be more difficult to fund and fill with activities. If you would like more information on these holidays please contact the RMBI.

The 2016 President of the Friends, Rw Bro Geoffrey Dearing Provincial Grand Master for East Kent would welcome your support during his stewardship.
